2023 ANNUAL REPORT

In 2023, Feeding Medina County served a record-breaking number of people. Despite the increased demand we were able to continue to nourish our neighbors in need with fresh, nutritious meals through our food distributions, as well as through the on-site pantry, and delivery programs. By providing nutritious, well-balanced foods to those we assist, we aim to help individuals and families thrive and lead healthier lives.

Feeding Medina County is dedicated to developing innovative strategies to combat hunger in our local community. A notable success story is a local collaboration with the Medina County Park District and Hope Recovery Community.

In May 2022, the Medina County Park District (MCPD) was chosen to manage the renowned farm at 4092 Medina Road by the executors of the Brown-Trump estate. This 17-acre property, previously owned by Mr. Edson J. Brown and Mr. Ross M. Trump, antique dealers, was to be preserved for cultural, educational, and aesthetic purposes.

To realize this vision, MCPD collaborated with Feeding Medina County and Hope Recovery Community in an award-winning initiative. While the park district oversees the farm, Hope Recovery manages the property, including the houses and barns. A portion of the land was transformed into a garden tended by Hope Recovery residents, who cultivate vegetables donated to Feeding Medina County. In 2023, over 1,000 pounds of fresh vegetables were grown and supplied to Feeding Medina County.

Feeding Medina County's participation in this project is made possible by the hard work and dedication of one of our long time volunteers and Master Gardener, Mary Ogden. Mary helps coordinate garden activities from April through October at the Brown-Trump Homestead making sure the garden is in tip top shape and producing at the highest level possible. The home grown vegetables produced at the Brown-Trump Homestead are distributed at all of our Food Distributions, as well as through the Staples for Seniors+ and Emergency Pantry Programs. This home grown collaboration is making a real difference in the lives of families here in Medina County.

This Garden is a great example of the cooperation and coordination between local organizations. Thanks to the partnership created between Feeding Medina County, Medina County Park District, and Hope Recovery Community, we were able to create a garden site capable of providing fresh vegetables for distributions, volunteer opportunities for Hope Recovery residents, and turn a wonderful green space back into a working farm.

EMERGENCY PANTRY & DOORDASH

Medina County residents can make an appointment to pick up food directly from our warehouse if they need food immediately. Additionally, through a partnership with the Akron-Canton Regional Foodbank and DoorDash, we are able to deliver fresh groceries to homebound seniors and disabled adults. In 2023 we served 1329 individuals through these programs.

Our volunteers pack over 450 bags once a month for seniors and disabled adults in subsidized housing units across Medina County. This program provides participants with 30+ pounds of shelf-stable essentials, fresh produce, high-quality meat, and dairy products delivered right to their residence each month.



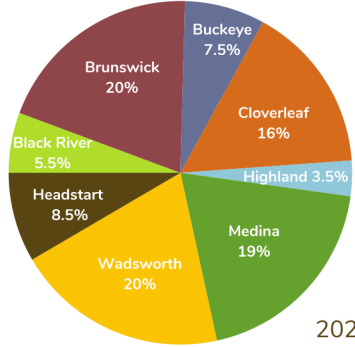
FOOD DISTRIBUTIONS



Our Food Distributions occur monthly in Brunswick, Lodi, Medina, and Wadsworth. At these drive through events families are provided with a variety of groceries including meat, dairy, fresh produce, and dry goods. Volunteers help by loading each vehicle with 60 to 80 lbs. of food for each household that comes through the distribution.

PANTRY DELIVERIES

In 2023, we transported 562,883 pounds of food for free from the Akron-Canton Regional Foodbank to 14 pantries in Medina County. These complimentary deliveries eliminate the \$100 per order delivery charge for smaller pantries and the need to travel to and from Akron.

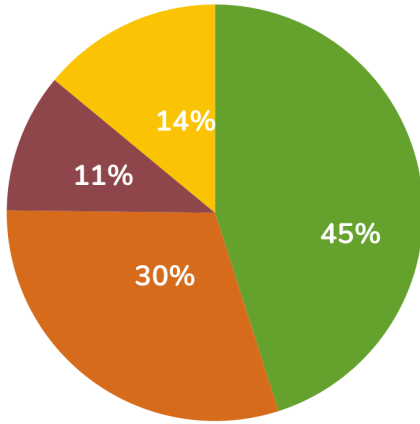

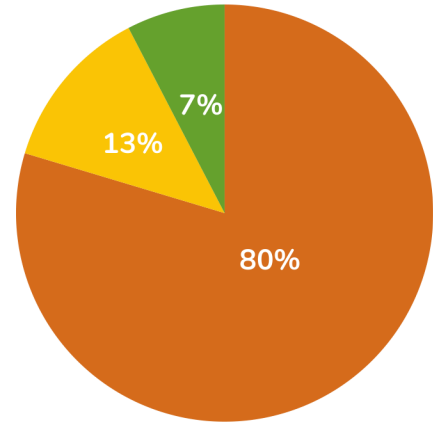
