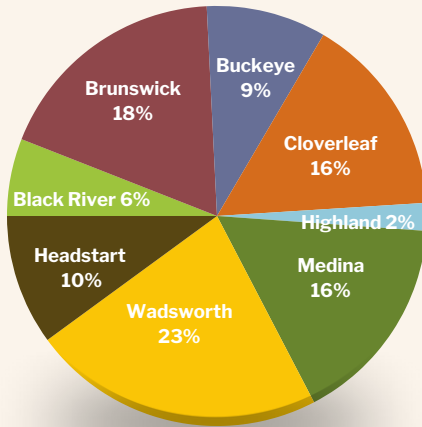

## WEEKENDERS FOR CHILDREN

The Weekenders Bags for Children program supplies food to over **1,050** elementary, middle, and high school students in Medina County each week. This initiative ensures that children in need receive nutritious meals on weekends and during extended school breaks, including the summer months.

## STAPLES FOR SENIORS+

Our volunteers pack over **460** bags once a month for seniors and disabled adults in subsidized housing units across Medina County. This program provides participants with 30+ pounds of shelf-stable essentials, fresh produce, high-quality meat, and dairy products delivered right to their residence each month.

## PANTRY DELIVERIES

In 2023, we transported **562,883** pounds of food for free from the Akron-Canton Regional Foodbank to 14 pantries in Medina County. These complimentary deliveries eliminate the \$100 per order delivery charge for smaller pantries and the need to travel to and from Akron.

## FOOD DISTRIBUTIONS

Our Food Distributions occur monthly in Brunswick, Lodi, Medina, and Wadsworth. At these drive through events families are provided with a variety of groceries including meat, dairy, fresh produce, and dry goods. Volunteers help by loading each vehicle with 60 to 80 lbs. of food for each household that comes through the distribution.

Our biggest distribution event of 2024 took place on November 26th, where we served **1,038** individuals.



## EMERGENCY PANTRY & DOORDASH

Medina County residents can make an appointment to pick up food directly from our warehouse if they need food immediately. Additionally, through a partnership with the Akron-Canton Regional Foodbank and DoorDash, we are able to deliver pantry staples to homebound seniors and disabled adults. In 2024 we served **1,177** individuals through these programs.

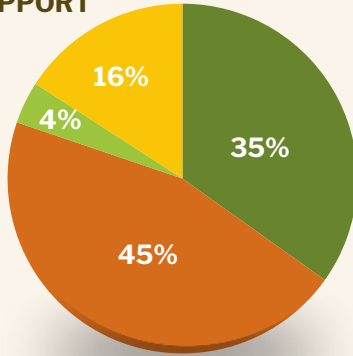

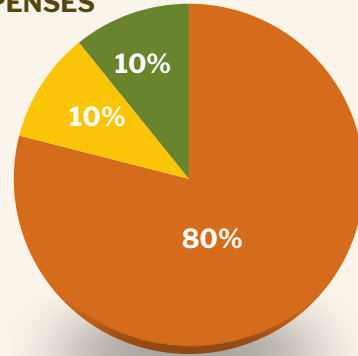
## REVENUE & SUPPORT

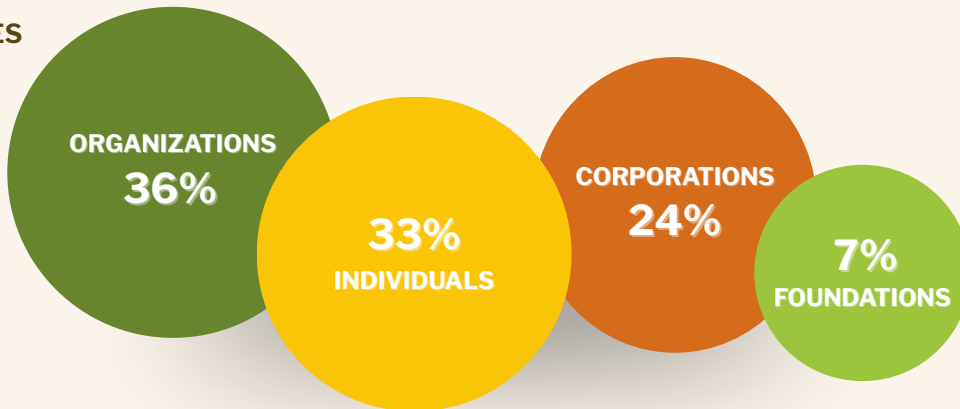
## EXPENSES
